### **Availity Essentials Migration Schedule Update**

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding the migration from the Molina Legacy Provider Portal to Availity Essentials.

#### What you need to know:

As previously communicated, Molina Healthcare scheduled all providers to migrate to Availity Essentials starting July 25th. Given the various levels of provider readiness, we are going to migrate a set of states each month rather than all providers at once. You are receiving this communication because will not be migrating on July 25th.

#### When this is happening:

We will provide an update on migration timing, once available. While the scheduled migration will not occur July 25th, we encourage all providers to begin using Availity and help limit the risk of issues when direct login access to the Molina Legacy Provider Portal is removed.
