

2024 Molina Member Rewards Program

Only for Molina Washington Apple Health (Medicaid) Members

Did you know? Molina Healthcare gives **rewards*** to our Apple Health members for getting important health screenings. **See below for a list of reward-eligible wellness visits and screenings for you and your family.**

Child Rewards

- **30 Month well-child visits** **\$50 Reward** Take your child in for six well-child visits in the first 15 months of life AND two well-child visits between 15-30 months.
- **Childhood immunizations** **\$50 Reward** Make sure your child gets all required immunizations (shots) before turning 2 years old.
- **3-11 Year well-care visits** **\$50 Reward** Make sure your child gets one well-care visit each year during the ages of 3-11.
- **ADHD medication follow-up visit** **\$75 Reward** Take your child (ages 6-12) in for a follow-up visit within 30 days of the pharmacy filling their initial medication for attention-deficit/hyperactivity disorder (ADHD).

Preteen and Young Adult Rewards

- **Immunizations for adolescents** **\$25 Reward** Make sure your preteen gets all required immunizations (shots) before turning 13 years old.
- **12-21 Year well-care visits** **\$25 Reward** Make sure your teen/young adult gets one well-care visit each year during the ages of 12-21.
- **Chlamydia screening** **\$25 Reward** Get an annual chlamydia screening (women**, ages 16-24).

Maternity Rewards

- **Prenatal visit** **\$100 Reward** Visit your provider for prenatal care during the first months of your pregnancy. If you are new to Molina and are more than three months into your pregnancy: see your provider within 42 days of joining Molina.
- **Postpartum visit** **\$50 Reward** Visit your provider for postpartum care between seven-84 days after you have your baby.

Cancer Screening Reward

- **Breast cancer screening** **\$100 Reward** Get an annual mammogram as recommended (women**, ages 50-74).
- **Cervical cancer screening** **\$50 Reward** Have an annual cervical cancer screening as recommended: Pap smear or HPV test (women**, ages 21-64).

Diabetes Screening Rewards

(Members with type 1 or 2 diabetes, ages 18-75 only.)

- **Diabetes HbA1c test** **\$35 Reward** Get your HbA1c tested during the year.
- **Diabetes eye exam** **\$35 Reward** Get your diabetic eye exam once a year.

Claim your rewards in a snap!

Here's how it works:

- 1) Complete one or more of the healthy wellness visits or screenings mentioned above.
- 2) Log in to your My Molina member portal account.
- 3) Click on the "My Wellness" tab, then click the "My Healthy Rewards" tab.
- 4) Click on the "Request Submission" button to view the secure online form.
- 5) Fill out the form with details of the health screening(s) you have completed.
You can submit multiple screenings at the same time.
- 6) Click the "Submit" button, and you're done!

Reward delivery:

You will receive your reloadable reward card in the mail with a welcome letter outlining additional information about your card (allow 2 to 4 weeks for delivery). If you have already received your card it will be reloaded with the reward amount (allow 1 to 2 weeks).

Important information:

- Apple Health members can get up to \$200 in total rewards every 12 months.
- Each reward can be received no more than once a year. For example, a diabetes HbA1c test can be completed every three to six months, but you can receive only one \$35 reward each year.
- All reward submissions for services completed in 2024 must be submitted by 1/31/2025.

Please Note: Rewards can be submitted under either an individual's My Molina® member portal account or under the primary insurer's account. If you do not have an account, you will need to create one or call Molina Member Services at (800) 869-7165, (TTY: 711) for help claiming your reward further.
