Hepatitis-C Initiative

MDHHS has entered into a three-year agreement with the manufacturer AbbVie to expand access to the Direct-Acting Antiviral (DAA) MAVYRET® (glecaprevir/pibrentasvir) for Medicaid and Healthy Michigan Plan beneficiaries. MAVYRET is an oral prescription medication used to treat adults and children ages 12 and older with HCV. In most cases, the treatment regimen is three pills taken once daily for eight weeks. **Starting April 1, clinical prior authorization (PA) is no longer required for MAVYRET when prescribed in accordance with Food and Drug Administration-approved labeling.** This includes removal of the requirement that HCV medications must be prescribed by or in consultation with a specialist. **All providers who have prescriptive authority will be able to prescribe this treatment to beneficiaries with HCV.** For more information on this, please see a copy of the fax blast that is included in this material.

As 2021 is ending, a gentle reminder that the deadline to submit supplemental data is January 15, 2022 to count towards the 2021 HEDIS measurement year. The deadline for claims and EMR/Registry data exchange is March 31, 2022 to count towards the 2021 HEDIS measurement year.
