Telehealth Billing Reminders for Medicaid

Federal Qualified Health Clinics and Rural Health Clinic recoveries

Molina will be recovering payment for claims billed on an incorrect claim form. This has caused encounters to not be accepted by Michigan Department of Health & Health Services (MDHHS). Medicaid PCP Payment Update

In mid-April Molina received and configured a primary care fee schedule change effective Jan. 1, 2021. All Claims after 4/19/21 have been paid in accordance with the revised Jan. 1 Medicaid fee schedule. EviCore transitioning PAs back to Molina

Effective September 1, 2021, prior authorization requests and medical coverage appeals for Molina Healthcare members that are currently required to be submitted through eviCore will transition back to Molina.
