CMS offering COVID-19 Vaccine Toolkits & significant cost determination

The Centers for Medicare and Medicaid Services (CMS) now have released toolkits for administering the COVID-19 vaccine. Medicare payment for COVID vaccines administered during calendar years 2020 and 2021 to Medicare Advantage (MA) beneficiaries will be made through the Medicare FFS program. January is Cervical Cancer Awareness Month

Cervical cancer is one of the most common causes of cancer death for American women. Regular screenings and early detection can find pre-cancers and help women protect themselves from cervical cancer and the Human Papillomavirus (HPV).

The American Cancer Society recommends that individuals with a cervix follow these guidelines to help find cervical cancer early:

- Cervical cancer testing (screening) should begin at age 25.
- Those aged 24-65 should have a primary HPV test every 5 years. If primary HPV test is not available, screening can be done either a co-test that combines with an HPV test with Papanicolaou (Pap) test every 5 years or a Pap test alone every 3 years.
- Those over the age of 65 who have had regular screenings in the past 10 years with normal results and no history of CIN2 or more serious diagnosis within the past 25 years should stop cervical cancer screenings.
- People who have been vaccinated against HPV should still follow these guidelines for their age groups.

*Best practices: As a reminder, cervical cancer screenings can be completed during annual Pap tests, well sick visits, urine pregnancy test, UTI screenings or Chlamydia/STI screenings.
