Molina Healthcare of Nevada believes that preventative care achieved through annual wellness visits is a cornerstone of our mission of improving the health and lives of our members. We recognize the importance of these visits in proactively identifying underlying conditions that require further care and establishing needed relationships with their medical providers. These cannot be achieved without your assistance and dedication. We appreciate your support in this mission.

As such, the Molina Healthcare of Nevada leadership team is excited to announce a program in place intended to provide incremental compensation to our providers for delivering these essential visits: **Molina Healthcare of Nevada Commitment to Wellness Push 2024.** 

Details of this exciting program include:

- Molina Healthcare of Nevada will process applicable claims to add an incremental \$30 wellness payment to providers for claims described below, in addition to normal claims processing guidelines.
- Applicable claims will be reprocessed in 2025 to include this incremental payment by 1/31/25.

The following table applies to the first claim for a Molina Healthcare of Nevada Medicaid member for one of the qualifying codes below submitted and accepted as a clean claim prior to 11/15/2024, for a date of service from 6/1/2024 through 9/30/2024. Providers are eligible for one claim per member.

This excludes members who received qualifying services with a date of service of 1/1/2024 through 5/31/2024.

Only one \$30 incremental payment per eligible Molina member.
